

Soaring Student Activities Sponsorship | by Tongass Federal Credit Union

Tongass Federal Credit Union is proud to support our youth members through the Soaring Student Activities Sponsorship program. Its purpose is to encourage our youth members to participate in extra-curricular activities such as sports, music, dance, and other school activities, and help alleviate participation expenses. The Soaring Student Activities Sponsorships are available to individual students and organized groups of students to help with travel expenses, registration fees for special events, school activities fees, etc.

ELIGIBILITY CRITERIA

- ✓ Must be a TFCU member or the child or grandchild of a member between the ages of 8 and 18.
- ✓ To be considered for the Soaring Student Activities Sponsorship, the application must be completed and submitted in full.
- ✓ The Soaring Student Activities Sponsorship will only be awarded to youth who are participating in activities organized or sanctioned by a school district, community organization such as Dribbler's League, or local youth groups with school approval or letter of support.
- ✓ To be considered for a Group Activities sponsorship, the group must have at least one person in it who is a TFCU sponsoring member. If the school is a TFCU member, any sanctioned group from that school will be eligible.
- ✓ Have fun and represent Southeast Alaska in a positive manner!

FUNDING PROVIDED IF AWARDED

Current TFCU youth members are eligible for one \$150 sponsorship per calendar year. Groups are eligible for up to six student sponsorships for a maximum of \$750 sponsorship per calendar year. Scholarship awards are subject to available program funding.

1. An individual application must be completed by the parent/guardian of the TFCU youth member.
2. Individual applicants may request reimbursement for costs incurred and provide proof of purchase, or request payment directly to an organization for activities fees or travel.
3. A group application must be completed by the sponsoring member or school representative.
4. Group applicants may request reimbursement for costs incurred and provide proof of purchase, or request payment directly to an organization for activities fees or travel. Group applicants may also request the sponsorship be paid directly to the school.

If awarded, TFCU would love to receive a picture of your child/children participating in their activity so can celebrate them by including it in our quarterly newsletter and in other public relations materials.
